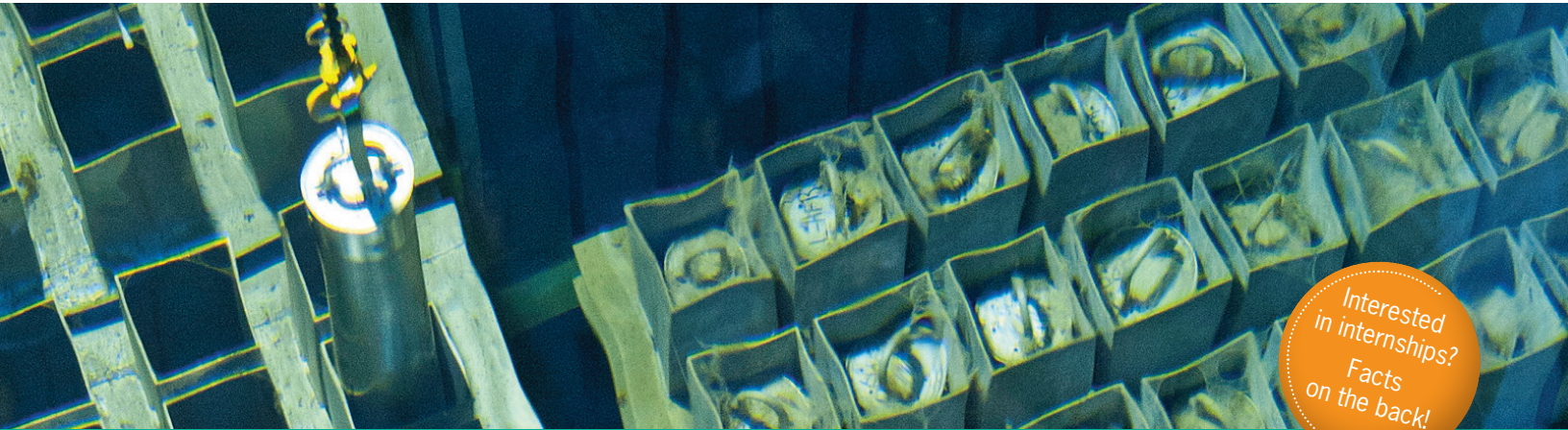

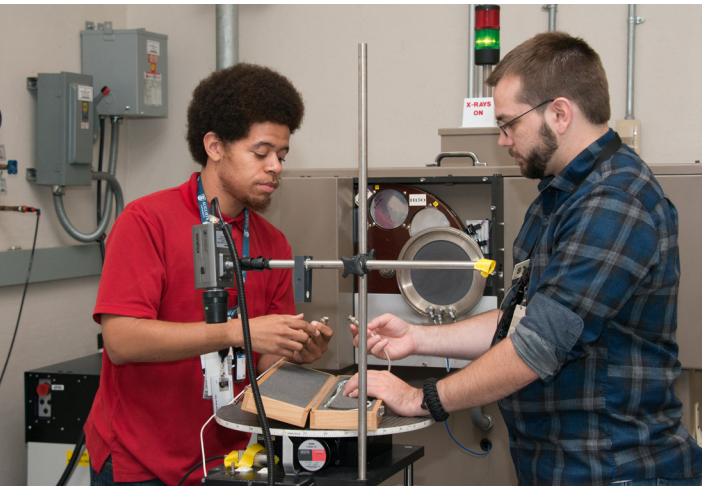

Eligibility and Criteria

- U.S. Citizenship Required for Security Cleared Positions. See DOE Order 472.2
- Must be a full-time student at an accredited two-year technical or four-year college or university, or within one year after finishing a degree program
- Must have completed freshman year of college or technical school
- Must possess a cumulative GPA of at least 2.5 (verified by most recent transcript)
- Must successfully complete Savannah River Site General Employee Training and substance abuse processing

Registered Apprenticeships



As an integral partner in the **Central Savannah River Area (CSRA)**, SRNS has established a Registered Apprenticeship Program that currently consists of multiple technical/professional occupations in partnership with Apprenticeship Carolina and the Lower Savannah Council of Governments.

These registered apprenticeships typically begin as limited service employment positions and are expected to last approximately 1-4 years during which time the apprentice will complete on-the-job training (OJT) and classroom training while earning a scalable wage. Each program is designed to train apprentices on the processes necessary to perform as a qualified full service employee in the specific discipline.

Upon successful completion of the program, participants receive a national, industry recognized and portable credential through the Department of Labor. There is no guarantee of future full-service employment upon completion of an apprenticeship.



earn a competitive scalable wage



complete on-the-job training under the guidance of a qualified full-service employee (FSE) or instructor (OTJ)



complete classroom training at SRNS and/or with a college/university



earn a nationally recognized and portable credential from the Department of Labor

Entry Requirements Needed

- Must be 18 years or older
- U.S. citizenship required for security cleared positions. See DOE Order 472
- Must successfully complete Savannah River Site General Employee Training and substance abuse processing. See page 2 for the basic qualifications of each position
- Skilled technician candidates must have completed ACT WorkKeys Skills assessments and achieved the minimum scores noted below. See page 2 for the WorkKeys modules associated with each position.
 - Workplace Observation (Score of 2 or higher)
 - Locating Information (Score of 4 or higher)** OR Graphic Literacy (Score of 3 or higher) NOTE: Graphic Literacy replaced Locating Information 10/1/17.
 - Applied Technology (Score of 4 or higher).
 - Reading For Information (Score of 4 or higher) or Workplace Documents (Score of 4 or higher)
 - Applied Math (Score of 4 or higher)
- ACT WorkKeys is a job skills assessment system which measures foundational and soft skills. The assessment is offered at multiple test sites. Visit this website to find a testing center near you and learn more about ACT WorkKeys: [Test Site Locator Form](#) (act.org)

* Test scores must be within the last five years.

**For Radiological Protection Inspector, a score of 3 or higher is needed for the Locating Information module.

Youth Apprenticeship Entry Requirements Needed

- Must be 16 years or older
- U.S. citizenship required for security cleared positions. See DOE Order 472.2
- Shall be a high school junior pursuit of a high school diploma. All apprentices must have obtained a high school diploma prior to successful completion of apprenticeship.
- Must successfully complete Savannah River Site General Employee Training and substance abuse processing. See page 2 for the basic qualifications of each position

A resume is not required at this point in the process. Searches can be viewed in the candidate zone. The search expires in 90 days, and the candidate will receive an email reminder of expiration.

How to apply

The Application and Interview Process

to become an employee of Savannah River Nuclear Solutions



To look for a position with SRNS, go to savannahrivernuclearsolutions.com/careers/careers.htm

- Hit “Apply Now.”
- Search for the available opportunities.
- If you haven’t already, create an account so that you can “Submit to job.” Be sure to review your resume carefully before you submit.



A recruiter in SRNS Talent Acquisition will review your resume.



If you qualify, your resume is forwarded to the hiring manager for consideration.



If the hiring manager selects you as a candidate, the recruiter will invite you to an interview.

- Your interview may be completed via telephone, video-conference, or in-person.



If the hiring manager selects you for an offer, SRNS Talent Acquisition will ask you to submit a few pre-hire documents for additional review of your work and academic history.



A recruiter will contact you with a verbal offer via telephone call and then a written offer via email.



If you accept the offer, you will be subject to SRNS hiring requirements, which include:

- Acceptable background check
- Accurate and consistent pre-hire documents
- Drug and alcohol testing
- Proof of complete COVID-19 vaccination
